TIME: Athlete check-in and late registration begins at 2:30 P.M.
Field events start at 3:30 P.M.
Running events begin at 7:30 P.M.

LOCATION: Halstead High School Track in Halstead, Kansas

The city of Halstead is located approximately 30 miles northwest of Wichita, about 28 miles east of Hutchinson, and about 12 miles west of Newton. To reach Halstead from Newton, take U.S. Highway 50 west for approximately 12 miles to Highway K-89. Turn left (south), and then drive two miles south to the intersection of Main Street and 6th. Turn right (west) and travel one-half mile. The Halstead High School Track is on your left just south of the tennis courts.

EVENTS: Shot Put, Discus, Long Jump, Triple Jump, Standing Triple Jump, 100 Meters, 200 Meters, 400 Meters, 800 Meters, and the One Mile Run.

AGE GROUPS: Open to both men and women ages 19 and older. Age groups are as follows: 19-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, 75-79, 80-84, 85-89, etc.

AWARDS: Medals will be given to the top 3 finishers in each age group for both men and women.

ENTRY DEADLINE: Entries must be postmarked by September 29, 2015. After that late entry fees will apply which are \$15 for the first event, and \$10 for each additional
